Terms and Conditions for Transfers

Booking:

- All transfers require pre-payment and a set time for departure.
- Early departures can be arranged depending on the availability with no additional charges.
- Late departure will be fined at the rate of 1\$ per minutes, up to 30 minutes from the
 selected time. Later than 30 minutes, booking will be considered as a NO Show, unless prior
 arrangements have been made. (kindly please choose a time wisely and make sure you are
 available to the chosen time and in case of getting delayed please contact us inform us to
 avoid such penalties, because we have schedules to follow, a delay for one client will cause
 delay for all our transfers)
- It is traveler's responsibility to arrive to the boat or contact us on time, location and contact details will be provided with confirmation mail and an airport representative will be waiting for you at the international terminal, however on busy arrivals we might not be able to locate you, in such cases immediately visit the airport help desk with your booking.

Payment:

Cancellation Policy:

- Cancellations need to be made in writing contact@maldivestour.guide and Maldives Tour Guide shall send a confirmation mail within 24 hours.
- The standard no cancellation fee for this service is 2 days prior to the departure time.
- Less than 2 days, 50% will charged.
- Less than 24 hours or no shows, 100% will be charged.
- Booking amendments by either Party needs to be done in writing and the receiving Party shall confirm reception of this mail within 48 hours.

 Later than 30 minutes, booking will be considered as a NO Show, unless prior arrangements have been made.

Force Majeure

The performance of this agreement by either party is subject to acts of God, war, government regulation, disaster, strikes, civil disorder, curtailment of transportation facilities, or other emergency making it inadvisable, illegal, or impossible to perform their obligations under this agreement. Either party may cancel this agreement for any one or more of such reasons upon written notice to the other party with supporting documents prior to the transfer time.

Refund Policy:

All refunds require customer bank account details and refund will be processed by bank transfers only. Processing time will be within 30 days of customer request.

Any transaction costs are to be borne by the buyer only.

I also hereby hold harmless the 'Sponsors' and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages, and liabilities arising out of, connected with, or resulting from my service at Maldives Tour Guide, including, without limitation, those resulting from the manufacture of vehicles, service delivery, possession, use or operation of all equipment used in the Hotels, activities and transfers. I hereby release the Sponsors from all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMINTY AGREEMENT
